#### 3. 2023/2024 Basketball Season - Tony Wooden & Kyle Kamm

Lengthy discussion on what MYSA plans are for Travel Basketball in the 2024 season.

A lot of the discussion surrounded what was best for all of our Travel basketball participants, MYSA, GHAA, and how kids from Metamora would be affected by combining travel teams again.

We also accounted for the future success of the Metamora and Germantown grade school programs as well as the high school programs.

Tony presented information about the surveys that we sent out after last season and the support for combining again, but many on the board felt that combining may result in Metamora players not getting a chance to play on a travel team since GHAA was unwilling to accept Metamora players. The concern was if we were inadvertently driving kids away from basketball.

Ultimately, it was decided to put forth a vote to allow kids that are in the Metamora Township High School School District to play on the MYSA Travel basketball program.

Additionally, Tony Wooden, Keith Helwig, Ryan Otto, and Kyle Kamm will be the board representatives of the MYSA Basketball Committee and will start working to generate plans for the upcoming 2023/2024 season as well as ways we can improve our basketball program in the future.

**Motion to the Board:** MYSA will allow participants from the whole of Metamora Township High School District to register and tryout for the MYSA Travel Basketball program for current and future years.

#### 4. Baseball, Softball, Tee-ball Overview

We had a brief discussion about the ongoing Spring/Summer 2023 Bat-and-ball season as well as some of the difficulties we have encountered so far.

We will work on a better process for evaluations and team placements for 8U baseball, including only allowing evaluations to drive team placements.

We will improve the scheduling process for teams and fields using our new website and TeamSnap for the 2024 Spring/Summer season/

We would like to open registration sooner to allow for a stricter registration deadline. We would like 8U Baseball and Tee-ball's schedule to coincide with the older players, allowing for more time for uniform orders and sponsorship arrangements.

Nikki Krischel will look into medals vs. trophies this year for our bat-and-ball participants under the 8U level and present options to the board for approval. Any teams that compete in Washington Park District will be competing for trophies in that tournament.

Chris Urban will confirm the umpire pay, process for payment, and umpire scheduling with Washington Park District. We also need to confirm the Win/Loss tracker for each age division and how we submit scores.

We brought up the idea of letting coaches decide if they would prefer to use \$6.00 per participant for an end of season party, or trophies similar to GHAA, but it was decided to table this until next year.

#### 5. New Baseball Director

We are in need of a new Baseball Director to take over after Marcus Camp decided to vacate his position and leave the MYSA Board of directors. We asked everyone to start asking around for involved members of our community to join the board and be voted in as Baseball Director.

#### 6. MYSA Legal Status, Tax Exempt Status, and Non-Profit Status Update - Chris Urban

Chris Urban provided an update on our legal and IRS filings, and explained that the Executive Board has agreed to have Gary Schmidt listed as the Registered Agent for MYSA. This allows the lawyer to have advanced warnings on any lawsuits and complete our tax filings each year.

#### 8. MYSA Website and TeamSnap Review - Derek Quam & Keith Helwig

Derek and Keith will provide additional updates on the progress with the website at a later date. Little work has been done due to other ongoing priorities.

#### 9. DBA & Branding Discussion - Chris Urban

Additional discussion on this is forthcoming, but Chris Urban had sought the pricing from Courtney Kamm Design for a brand refresh as part of our website and registration upgrade. Chris Urban will seek quotes from additional graphic design companies for a brand refresh and we can vote on new brand ideas in a future meeting.

Additionally, we need to discuss the direction and naming of the association as it relates to our future plans, direction, values, mission, and goals. Table larger discussion until the June Board Meeting.

#### 10. Sponsorship Committee Overview - Dave Stomberg

After a brief discussion about what is needed for Old Settlers Days (new logo/signage/shirts/banner (for parade) we decided that we are not in a position to be in Old Settlers Days this year and will prioritize the brand refresh before we order new signage or member shirts.

#### 11. Capital Improvements Overview

Update was given regarding Lower St. Mary's field. MATBO has harley raked and spread the new top dirt on the field. Lower St. Mary's still needs a new home plate and new base posts. We have the Home plate and will work to get it installed as well as getting new base posts for that diamond. Ryan Otto will work to get plate and base posts installed.

Since the diamond has been harley raked some weeds have returned and it needs to be sprayed again.

Chris will work with interested members of the board to provide the park district a potential layout and quote for the cost of putting in a new diamond at BPP as well as a

new building (storage and concessions) and batting cages. The Park District may have approved batting cages in a previous year for Black Partridge Park. Matt Bidne will investigate that with the Park District.

Also we need new dirt on all fields and to realign home plate, mounds, and bases at Black Partridge Park. Chris and Ryan will work with the Park District on this process.

#### 12. Approve Park District Participant Fee

Chris Urban explained that per MYSA's contract with Metamora Park District, we are obligated to pay the Park District a \$5.00 participant fee and \$1.00 land rental fee.

# 13. MYSA Interest in assisting Metamora Park District with Parking for Pro-Am Golf Tournament at Metamora Fields

Chris provided information that the Metamora Park District was seeking interest from partnering organizations to see if they wanted to assist with paid parking at Black Partridge Park for the ProAm golf tournament at Metamora Fields, June 26th – July 2nd.

It would require 5 parking attendants per day to park roughly 500 vehicles. MYSA would receive some portion of the parking fees which could be from \$5.00 to \$10.00. The Park District would provide the shuttles to the golf tournament. MYSA could pick a single or more than one day that week to assist with parking.

After discussion, the board was interested, but the following questions needed to be answered before we could vote to approve our assistance:

- What percentage of the parking fee would MYSA get?
- What will be the cost of parking?
- How many days does the park District expect (or will the park district allow)
   MYSA to assist with parking?
- Can we pay parking attendants?
- How long do you expect the days to last (how long will the parking attendants need to work?
- How can we effectively ensure that activities at the park (Baseball, softball, tee-ball) would not be affected by golf parking?

There were also concerns about if MYSA could get enough volunteers to cover the days/times needed.

Chris Urban will reach out to the Park District for the answers and provide them back to the board before we decide any go-forward plans.
